Day Hike Waiver and Release of Liability

READ BEFORE SIGNING

Indemnity:

Neither the Santa Rosa Band of Cahuilla Indians nor the United States Government, nor their officers, agents, or employees, shall be liable for any loss, damage, or injury of any kind whatsoever (including without limitation, death) to the person or property of the Visitor any other person whomsoever, caused by any use or condition of Tribal Lands or by any defect in any structures. Visitor hereby releases and waives any and all claims against the Santa Rosa Band of Cahuilla Indians and the United States Government and agrees to indemnify and hold the Santa Rosa Band of Cahuilla Indians and the United States Government harmless from and to defend them against any death, loss or damages of whatsoever kind or nature, including any claim or liability for any loss, damage, or injury arising from the use or condition of Tribal Lands together with all costs and expenses.

Visitor agrees to hold the Tribe and its officers, directors, agents and employees harmless from any and all actions, causes of action, claims, demands, cost, liabilities, expenses and damages to personal property (including attorneys' fees) arising out of injury to said visitor.

Visitor shall not light any fires on Tribal land for any reason, and will be held liable for any and all damages to Tribal lands and its structures by fire or other causes.

Visitor understands that the hiking permit is for day use only, no overnight camping.

Visitor shall not use any portion of Tribal Lands for any unlawful purpose, or for any purpose not expressly authorized by the Tribal Council.

Environmental Protection:

Visitor shall bear sole responsibility for ensuring compliance with all environmental protection requirements related to all of its uses of Tribal lands.

Visitor agrees to take all reasonable steps as may be needed to prevent activities on Tribal Lands from unnecessarily:

- (a) Causing or contributing to soil erosion or damaging forage or timber growth thereon;
- (b) Polluting air or water;
- (c) Damaging improvements owned by the Tribe or its members; and/or
- (d) Destroying, damaging or removing fossils, historic or prehistoric ruins, artifacts, or other traditional cultural, historical or archeological property.



Sovereign Immunity

Nothing noted in this Permit is intended to, nor shall it be deemed or construed to, constitute a waiver of the immunity of the Santa Rosa Band of Cahuilla Indians, a sovereign Indian Nation, from unconsented suit, and such sovereign immunity is and shall remain inviolable.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
